Ensuring the safety and security of Jewish campers and campgrounds during the summer is crucial. Here are the top ten things camp staff can do:

- Staff Training:** Train all staff members, including counselors, activity leaders, and administrative personnel, on security protocols and procedures.
- Emergency Response Plan:** Develop and regularly review an emergency response plan that includes procedures for various scenarios such as medical emergencies, severe weather, and security threats.
- Access Control:** Limit access to the campgrounds by implementing controlled entry points and ensuring that only authorized individuals are allowed onto the premises.
- Visitor Policies:** Enforce strict visitor policies, requiring all visitors to check in with camp staff upon arrival and provide identification if necessary.
- Security Personnel:** Employ trained security personnel to monitor the campgrounds, especially during high-traffic times or special events.
